Any and all corrections and or erasures must be initialed. **Each quote shall be signed in ink by an authorized representative of the respondent**. The contents of the quote submitted by the successful respondent of the ITQ may become part of the contract awarded as a result of this solicitation.

2.1 SCOPE OF WORK (SOW)

The Scope-of-Work ("SOW") contained in the Attachments describes the services expected for a Contractor to provide the STOFHD. Respondent must ensure that all such services contained in the SOW are provided for in every particular and shall meet or exceed the level of quality, availability, features, functionality, frequency, accuracy, and performance.

The silence of specifications or requirements as to any detail contained in this document or any of the attachments or exhibits, or the apparent omission from any specifications or requirements, or a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices shall prevail and that only material and workmanship of the finest quality are to be used. All interpretations of the Scope of Work shall be made on the basis of this statement.

Scope of work Bathroom Repairs

- Supply all labor and materials.
- All materials being installed shall be of equivalent make/model to the original material being removed. (Unless it has first been approved by the Housing Department)
- All work performed shall be as per code(s).
- Schedule of Values and proposed Schedule shall be submitted with proposals.
- Supply all drawings/prints and any other documentation needed by the Building Department.
- Clean up jobsite daily and before the final inspection of the completed job.
- Call the Building Department & Housing Department for all inspections, before and during the installation process. (Darryl Kinchen 954-279-4784)
- Contact Housing Department for final inspection, prior to leaving the jobsite.

General

Master Bathroom:

- Remove and replace bathroom vanity and countertop. (like for like) Laminate top shall include 4-inch matching laminate back splash. Countertop color samples shall be provided by awarded contractor to Brighton Housing Department for selection.
- Contractor shall reuse existing sink & faucet.
- Contractor shall identify and repair any existing leaks.
- Remove and reset toilet. A new wax ring shall be included.
- Remove existing shower door frame and replace with semi-frameless obscure glass bypass shower door system finish shall be bright chrome.
- Remove linen cabinet, repair all drywall as needed finish and paint to match existing, install matching base and install (5) five 16-inch-deep white vinyl coated shelves at 16" off floor and 16 inches on center.
- Remove and replace tile floor with life proof luxury vinyl plank flooring, color samples shall be provided by awarded contractor.
- Remove and replace broken glass pane in single hung window. (like for like)
- Paint entire bathroom, including ceiling, color to match existing.

Guest Bathroom:

- Remove and replace vanity and countertop, like for like. The laminate top shall include new 4-inch laminate back splash. Countertop color samples shall be provided by awarded contractor to Brighton Housing Department for selection.
- Contractor shall identify and repair any leaks.
- Contractor shall reuse existing sink & faucet.
- Remove and reset toilet. A new wax ring shall be included.

- Remove and replace tile floor with life proof luxury vinyl plank flooring, color samples shall be provided by awarded contractor.
- Paint entire guest bathroom walls and ceiling.
- Interior paint- All paint shall be semi-gloss.
- Install (2) topcoats as a minimum. Based on color additional coats may be required to ensure no bleed through or holidays.
- Install drop cloths, masking tape, wall curtains, etc. to protect existing finishes, equipment, furniture, etc.
- All painting preparation and installation to be done in accordance with manufacturers recommendations.
- Clean all overspray drips, runs, etc.
- Final clean, and dispose of all debris.
- Master bathroom shall be completed before starting in Guest Bathroom.

Contractor/Vendor Requirements:

- It is the contractor's responsibility to obtain any and all permits required to perform the task listed in the above Scope of Work.
