2.0 OBJECTIVE

Any and all corrections and erasures must be initialed. **Each quote shall be signed in ink by an authorized representative of the respondent.** The contents of the quote submitted by the successful respondent of the ITQ may become part of the contract awarded as a result of this solicitation.

2.1 SCOPE OF WORK (SOW)

The Scope-of-Work ("SOW") contained in the Attachments describes the services expected for a Contractor to provide the STOFHD. Respondent must ensure that all such services contained in the SOW are provided for in every particular and shall meet or exceed the level of quality, availability, features, functionality, frequency, accuracy, and performance.

The silence of specifications or requirements as to any detail contained in this document or any of the attachments or exhibits, or the apparent omission from any specifications or requirements, or a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices shall prevail and that only material and workmanship of the finest quality are to be used. All interpretations of the Scope of Work shall be made on the basis of this statement.

2.3 NOTIFICATION

Each respondent submitting a quote in response to this ITQ will be notified in writing as to acceptance or rejection of their quote. Release of notification letters should be within sixty (60) days of the quote submission date. STOFHD reserves the right to delay this action if it is deemed to be in the best interests of STOFHD.

Scope of work Impact Doors & Windows

- Supply all labor and materials.
- All materials being installed shall be of equivalent make/model to the original material being removed. (Unless it has first been approved by the Housing Department)
- All work performed shall be as per code(s).
- **Schedule of Values and proposed Schedule shall be submitted with proposals.**
- Supply all drawings/prints and any other documentation needed by the Building Department.
- Clean up jobsite daily and before the final inspection of the completed job.
- Call the Building Department & Housing Department for all inspections, before and during the installation process. (Darryl Kinchen 954-279-4784)
- Contact Housing Department for final inspection, prior to leaving the jobsite.

General

- Remove front entry door including side lights, back entry door, (2) sliding glass doors & the front four (4) windows to the right of the front entry door, dispose of debris.
- Supply all labor and materials to install Impact Rated Doors with composite jambs and fiberglass door slabs with impact glass, elevations shall be (like for like) front and back entry doors only. Provide associated trim & new hardware (like for like).
- Replace Sliding Glass doors with Impact Rated composite jambs, fiberglass French doors with integral mini blinds. Provide associated trim and new hardware.
- Replace the front (4) four windows with Impact Rated windows like for like, Grey Tint & low E.
- Repair all brick, mortar & interior wall finishes around openings and damaged windowsills shall be replaced by the contractor at no additional cost if damaged at removal or installation process.
- Doors, frames, & trim paint colors shall be (like for like) however, if other colors are desired awarded contractor shall provide color samples for TM's selection.
- Caulk, prime, paint, & stain on interior repairs made shall match as closely as possible.
- Caulk, brick, mortar repairs & paint exterior of all doors & windows shall match as closely as possible.
- Final clean all doors, windows and remove all debris from site.
