## **SECTION 2: GENERAL REQUIREMENTS**

### **2.0 OBJECTIVE**

The objective of this ITQ is to provide sufficient information to enable qualified Respondents to submit written quotes. This ITQ is neither a contractual offer nor a commitment to purchase any products or services. All information contained in the quote must be legible. Any and all corrections and erasures must be initialed. **Each quote shall be signed in ink by an authorized representative of the respondent.** The contents of the quote submitted by the successful respondent of the ITQ may become part of the contract awarded as a result of this solicitation.

### **2.1 SCOPE OF WORK (SOW)**

The Scope-of-Work ("SOW") contained in the Attachments describes the services expected for a Contractor to provide the STOFHD. Respondent must ensure that all such services contained in the SOW are provided for in every particular and shall meet or exceed the level of quality, availability, features, functionality, frequency, accuracy, and performance.

The silence of specifications or requirements as to any detail contained in this document or any of the attachments or exhibits, or the apparent omission from any specifications or requirements, or a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices shall prevail and that only material and workmanship of the finest quality are to be used. All interpretations of the Scope of Work shall be made on the basis of this statement.

### **2.3 NOTIFICATION**

Each respondent submitting a quote in response to this ITQ will be notified in writing as to acceptance or rejection of their quote. Release of notification letters should be within sixty (60) days of the quote submission date. STOFHD reserves the right to delay this action if it is deemed to be in the best interests of STOFHD.

**General Notes:**

- Schedules must be submitted with all bids and updated any time there is a change
- Contractors are expected to work Monday-Friday, 8:00am-5:00pm unless otherwise specified by the Project Manager
- All materials being installed shall be of equivalent make/model to the original material being removed. (Unless it has first been approved by the Housing Department)
- All work performed shall be as per code(s).
- **Schedule of Values and proposed Schedule shall be submitted with proposals.**
- Supply all drawings/prints and any other documentation needed by the Building Department.
- Clean up jobsite daily and before the final inspection of the completed job.
- Call the Building Department & Housing Department for all inspections, before and during the installation process. (Jacqueline Kaegi 863-623-7476)
- Contact Housing Department for final inspection, prior to leaving the jobsite

**Section 3: Specific Scope of work: Bathroom Remediation Renovation**

- Contractor should supply all labor, materials and supervision for a bathroom renovation for the following:
- Quarantine the entire bathroom with air scrubbers to contain contaminants, clean and sanitize
- Remove all drywall behind toilet and replace with moisture resistant drywall, texture and paint; remaining drywall remove lower 2 ft of affected wallboard materials as needed
- Replace all flooring with new like for like flooring
- Remove damaged vanity and replace with new vanity, countertop and faucet – like for like
- Remove bathtub and replace with new one (Ensure bathtub shower combo has shower pan, dur-rock, red-seal and is waterproof) Remove and reinstall vertical 24” grab bars on stud block walls: Remove and replace shower combo faucets
- Remove and replace damaged medicine cabinet and light fixture to match length of new vanity
- Remove and reinstall complete toilet
- Install bathtub tile to the top of ceiling; color is new beige or neutral colored wall tile 12’ x 24’ with 16’ grout lines - Member to verify exact style and color – like for like
- No glass shower enclosure – reinstall shower rod and curtain
- Check and repair and/or replace, if needed bathroom exhaust fan as well
- Painting walls semi-gloss paint – Verify with Member paint color
- Please ensure remove and dispose debris from the job site daily
