2.1 SCOPE OF WORK (SOW)

The Scope-of-Work ("SOW") contained in the Attachments describes the services expected for a Contractor to provide the STOF Housing Department. Respondent must ensure that all such services contained in the SOW are provided for in every particular and shall meet or exceed the level of quality, availability, features, functionality, frequency, accuracy, and performance.

Scope of work: Fence Installation

- Supply all labor and materials.
- All work performed shall be as per code(s).
- Place drop cloths, wall curtains, etc. to protect existing finishes, equipment, furniture, etc.
- Schedule of Values and proposed Schedule shall be submitted with proposals.
- Supply all drawings/prints and any other documentation needed by the Building Department.
- Clean up jobsite daily and before the final inspection of the completed job.
- Contact Housing Department for final inspection, prior to leaving the jobsite.

The Seminole Tribe of Florida (STOF) Housing Department is currently accepting bids from Florida Licensed Contractors for Fence Installment project located at:

1830 Canoe Circle. Lakeland FL. 33809

Project Scope

- Install 6'0 PVC Vinyl Fencing or 6'0 Black Chain-link Fencing, Starting 3 feet up on left corner of home. 54 feet along the left side of the home with a single gate. 197 feet long on left side, than Then 154.18 feet across the back with 1 single 5 foot gate, angled 103 feet to corner of rear property line. The right front side of home starting up 28feet from the corner of the home behind the AC condenser the fence would be 47 feet with a double gate (2, 5 foot gates) which should go from corner to corner of the property line. Along the right long side of the property the fencing should be 148 feet.
- Clearing needed on left side corner of property
- All post must be a minimum of 2 feet deep.
- Concrete must be used on all post.
- Survey to be included with bid.
- Clean up job site daily.
- Contractor is responsible for all debris removal.
- Contractor shall provide all labor, material, equipment & supervision to complete this scope of work.
- Contractor is responsible for scheduling all required inspections and notifying housing project manager Ruben J. Vellon at 863-582-1178 & must have a company representative present for all inspections.
