2.0 OBJECTIVE

Any and all corrections and or erasures must be initialed. **Each quote shall be signed in ink by an authorized representative of the respondent.** The contents of the quote submitted by the successful respondent of the ITQ may become part of the contract awarded as a result of this solicitation.

2.1 SCOPE OF WORK (SOW)

The Scope-of-Work (“SOW”) contained in the Attachments describes the services expected for a Contractor to provide the STOF Housing Department. Respondent must ensure that all such services contained in the SOW are provided for in every particular and shall meet or exceed the level of quality, availability, features, functionality, frequency, accuracy, and performance.

The silence of specifications or requirements as to any detail contained in this document or any of the attachments or exhibits, or the apparent omission from any specifications or requirements, or a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices shall prevail and that only material and workmanship of the finest quality are to be used. All interpretations of the Scope of Work shall be made on the basis of this statement.

2.3 NOTIFICATION

Scope of work: Fence Installation

- Supply all labor and materials.
- All work performed shall be as per code(s).
- Place drop cloths, wall curtains, etc. to protect existing finishes, equipment, furniture, etc.
- **Schedule of Values and proposed Schedule shall be submitted with proposals.**
- Supply all drawings/prints and any other documentation needed by the Building Department.
- Clean up jobsite daily and before the final inspection of the completed job.
- Contact Housing Department for final inspection, prior to leaving the jobsite.

Project Scope

- Install 6'0 PVC Vinyl Fencing or 6'0 Black Chain-link Fencing, Starting 10 feet up on left corner of home. 51.6 feet along the left side of the home with double gate (2, 5 foot gates). 50 feet long, than angled 70.2 feet to corner of rear property line. The rear fencing should be 239.70 feet which should go from corner to corner of the property line. Along the right long side of the property the fencing should be 190.50 feet. Starting 10 feet from the front right corner of the home, 59.9 feet along the right side of the home with a double gate (2, 5 foot gates).
- Clearing needed on left side corner of property
- All post must be a minimum of 2 feet deep.
- Concrete must be used on all post.
- Survey to be included with bid.
- Clean up job site daily.
- Contractor is responsible for all debris removal.
- Contractor shall provide all labor, material, equipment & supervision to complete this scope of work.
- Contractor is responsible for scheduling all required inspections and notifying housing project manager Ruben J. Vellon at 863-582-1178 & must have a company representative present for all inspections.
