Any and all corrections and or erasures must be initialed. **Each quote shall be signed in ink by an authorized representative of the respondent**. The contents of the quote submitted by the successful respondent of the ITQ may become part of the contract awarded as a result of this solicitation.

2.1 SCOPE OF WORK (SOW)

The Scope-of-Work ("SOW") contained in the Attachments describes the services expected for a Contractor to provide the STOFHD. Respondent must ensure that all such services contained in the SOW are provided for in every particular and shall meet or exceed the level of quality, availability, features, functionality, frequency, accuracy, and performance.

The silence of specifications or requirements as to any detail contained in this document or any of the attachments or exhibits, or the apparent omission from any specifications or requirements, or a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices shall prevail and that only material and workmanship of the finest quality are to be used. All interpretations of the Scope of Work shall be made on the basis of this statement.

2.3 NOTIFICATION

Scope of work ADA Shower Enhancements

- Supply all labor and materials Including and not limited to grab bars and shower bench
- All materials being installed shall be of equivalent make/model to the original material being removed. (Unless it has first been approved by the Housing Department)
- All work performed shall be as per code(s).
- Schedule of Values and proposed Schedule shall be submitted with proposals.
- Supply all drawings/prints and any other documentation needed by the Building Department.
- Clean up jobsite daily and before the final inspection of the completed job.
- Shower measurements are 35 inches wide by 59 inches long.
- Install Shower niche by left corner of shower 12in Wide by 18in Tall
- Install Bypass Shower door, Brushed Nickel, Model #SHDR-6360762G04
- Install a new Marble sill along bottom.
- Remove & install new shower kit per ADA standards.
- Replace toilet, must be Kohler highline
- Paint shower area, match existing paint, must be high gloss.
- Install one 42 inch grab bar and one 24 inch grab bar in the shower. Stainless Steel.
- Install one 24 inch grab bar on the right side of the toilet. Stainless Steel.
- Material must be provided for approval prior to install. Call the Building Department & Housing Department for all inspections, before and during the installation process. (Ruben J Vellon 813-246-3100)
- Contact Housing Department for final inspection, prior to leaving the jobsite.


General

- Demo Primary bathroom shower tub combo, remove all wall tile material, wall board, and replace insulation from floor to ceiling in tub/shower location. Dispose of all debris.
- Verify and correct if needed all stud spacing (shall be 16" OC), provide folding shower seat see attached specs (see page 7). Install required backing for grab bars, shower seat, and shower fixtures as required (See page 6).
- Relocation of existing drain is required per this scope, and shower floor shall slope to drain per ADA standards for zero entry ADA shower.
- Contractor shall provide 2-inch cultured marble threshold color to be selected by TM.
- Install approved shower pan before installation of mud bead, Red Guard liquid membrane is an approved substitution.
- Install durarock per manufactures specifications, use approved fasteners and apply liquid waterproof membrane over entire surface area of wall board and manufactures fiber mesh material shall be installed at all joints including inside corners, at floor and shower drain flange per manufactures specifications and Florida Building Code latest edition.
- Supply & install shower wall tile (like for like) from floor to ceiling & mosaic shower floor tile.
- Provide square foot price for tile to be included in quote.
- Paint entire bathroom walls & ceiling 2 coats each, Paint shall be semi-gloss.
- Supply new bathroom ADA shower fixture; (Model # 82611SRN) Brecklyn Single Handle 6-Spray
 Tub Shower Faucet w/ Magnetix Rain shower in Spot Resist Brushed Nickel (Valve Included)
 Brushed Nickel.
- Supply and install (2) stainless steel grab bars per ADA requirements & specifications (1) 42" & (2) 24" with concealed flange covers.
- Contractor shall provide and install (like for like) and 1 ceramic corner soap dish samples to be provided to TM for selection.
- Complete a final clean and dispose of all debris. .
- Chase wall shall receive new standard 90 degree corner bead on outside corner.
- Match dry wall finish as close as possible

Contractor/Vendor Requirements:

- It is the contractor's responsibility to obtain any and all permits required to perform the task listed in the above Scope of Work.
- A schedule must be provided before a PO will be requested.

Product Materials

FRAME: satin finish stainless steel, 11/2" HDPE support bar and 18 gauge 1"diameter tubing

MOUNTING FLANGES: 7 gauge satin finish stainless steel with three mounting holes provided in each flange for installation.

LOWER SUPPORT BRACKET: 16 gauge satin finish stainless steel.

SEAT: 1/2" thick solid phenolic. White matte finish Melamine bonded onto the phenolic for color. All exposed edges are machined smooth to a uniform dark finish.

Operation

Hinged seat folds up and out of the way when not in use. When properly installed, seat can support up to 400 lbs. – static load.

Installation

Verify all rough-in dimensions prior to installation. Provide concealed backing or anchors as specified by architect before finished wall is applied. Secure to wall with mounting screws (not included) at holes provided. Locate mounting holes at appropriate height above finished floor to meet seat height requirement. Secure lower support bracket to wall at appropriate location. Mounting kit available from Bradley. For more information, visit bradleycorp.

▲ WARNING: Be sure to use reinforced backing behind wall where mounting screws or anchoring devices are installed to ensure adequate support for the shower seat. All anchoring devices (supplied by installer) must be appropriate for specific wall construction. Severe personal injury and/or property damage may result from improper mounting.

Guide Specification

Folding white phenolic shower seat shall be ½" thick phenolic with Melamine bonded to its phenolic core. Secured to the frame of 18 gauge, 1" diameter tubing, and 1½" HDPE support bar. Support leg contained in 16 gauge lower support bracket. Shower seat must meet or exceed ADA guidelines.

Overall dimensions: 281/2"W x 15"D x 1/2" thick.


